DOES NET ZERO MEAN THE END OF LIVESTOCK AGRICULTURE?

With the global food system contributing up to an extra degree of warming by 2100, they cannot be ignored. Sensible policies are hindered by carbon footprinting conventions that distort the impact of methane in both directions.

This Gresham College lecture explains how understanding methane's true impact shows that a sustainable livestock industry could be compatible with a stable climate, although it would still need radical change.
