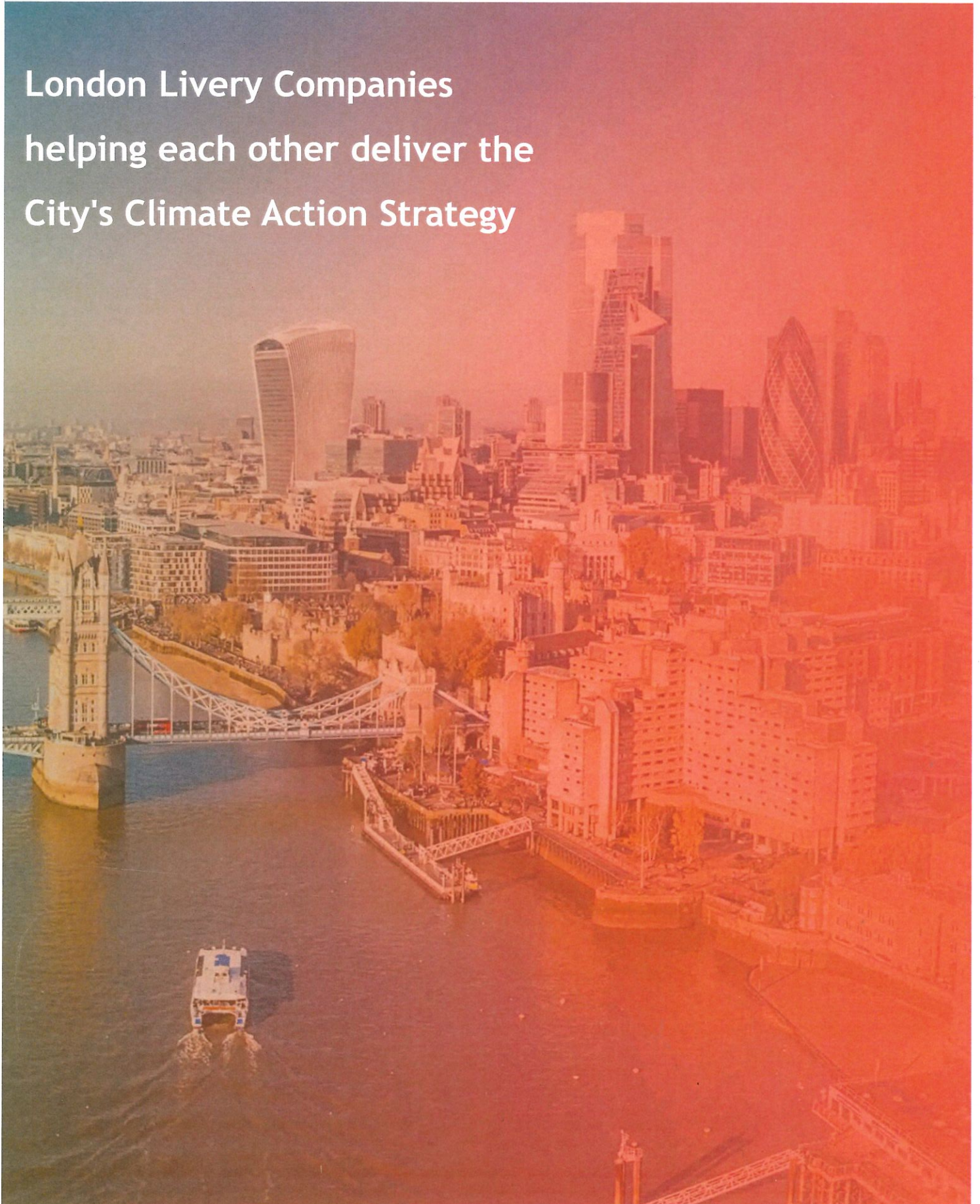

SPEAKER BIOGRAPHIES



Alison Gowman, Alderman

Alderman, Alison Gowman is the founder and Convenor of the Livery Climate Action Group. Having been a key party in the City Corporation's own Climate Action Strategy, she is driving the adoption of the 2040 target for net zero emissions by all within the Square Mile. She has spent her professional life as a commercial real estate lawyer in the City and is now a Consultant at DLA Piper UK LLP. She has been the Alderman for Dowgate Ward since 2002.



Emma Howard Boyd CBE, Chair Green Finance Institute

Emma has had an extensive career in financial services at the forefront of the climate change, environmental and sustainable finance agenda. She was Chair of the Environment Agency and an ex-officio board member of the Department for Environment, Food and Rural Affairs from 2016 to 2022.

She is currently independent Chair of the London Climate Resilience Review, Chair of the Green Finance Institute and a UN Global Ambassador for Race to Zero and Race to Resilience. Emma serves on several boards and advisory committees which include; Climate Arc, European Climate Foundation, Net Zero Task Force for the Duchy of Cornwall.

Emma was the UK Commissioner to the Global Commission on Adaptation from 2018 until January 2021.



Colin Hutchison, Managing Director, Architecture Line, Egis

Colin trained as an Architect and has 25 years of professional experience in both architectural and sustainable engineering firms. He has specialized in leading multidisciplinary design teams which focus on the performance, materiality and environmental impact of cities. He has led numerous PAS 2035 retrofit projects, especially through the SHDF programme and is pioneering PAS2038 delivery for historic and non-domestic buildings, focussing on the trigger points for retrofit and the heritage implications in doing so. His current interests include decarbonisation at a neighbourhood level recognising that buildings do not exist in isolation but are part of an interconnected landscape comprising of infrastructure, housing and commercial projects that can work together. He sees digital modelling and data as the keys to unlock these opportunities.



Tim Freeman, Managing Director of Energy Specifics Limited

Tim leads a consultancy specialising in energy efficiency building assessments and energy saving upgrades. Working with Jon Moorhouse they became the first company in the UK to achieve certification to PAS 2038 as I-Scan Ltd. The PAS defines technically robust and responsible "whole-building" retrofit processes for non-domestic buildings. He recognises the challenges of appropriate and compliant retrofitting of heritage buildings and the integration of BIM and state-of-the-art scanning technology to facilitate a data-led approach. They are also a leading PAS 2035 specialist in the social housing and domestic market have delivered over 2,000 homes under government schemes to date, taking primary responsibility for PAS compliance and Coordination.
