An Excellent Opportunity

Paul Sheedy of Unifi.id <u>https://www.unifi.id/en/our-solutions/</u> is a Livery member of the Constructors Livery Company. He has kindly offered to carry out surveys of all the Livery Halls to measure their carbon emissions – for free! He wants to use this information to benchmark efforts to lower these emissions. This is needed in the context of the Government target of net zero by 2050 and for the City of London by 2040. He has done this for four halls already and so if you want to learn from another Livery Company then you can take advantage of their personal experience. Paul spoke at the LCAG Conference about this and other topics regarding using data to measure occupational use and behaviour.

Highlights from our 24th July Online "All-SPOC Update" meeting of Company Representatives

<u>The Carmen Trial a Simple</u> <u>Means of Capturing the Carbon</u> <u>Footprint of a Livery Event</u>

At our July SPOC online meeting, Graham Funnell described his benchmarking initiative piloted at the Carmen's Cart Marking Luncheon at the Guildhall. Attendees were invited to scan a QR code zap on the menu that took them to a simple means of gathering their travel and accommodation data. His algorithm then calculated their carbon footprint fascinating and brilliant. We are all full of excitement about this and Graham has offered to share this for other Livery Companies' events. - to collect immediate and continuous comparative data to measure impact. Thank you, Graham for your generous and cutting-edge work. We were also impressed by the tightness of the GDPR data management and the simplicity of this first trial, which could be finessed in future versions. Feedback will be circulated via LCAG to raise awareness and then, possibly, be able to move towards data gathering on impact.

Liese Edgcumbe (Gold & Silver Wyre Drawers)

gave us a new dimension to address when reducing our carbon footprint: **data storage overload!** Individually we could try to reduce the number of emails, photos, emojis sent and hoarded. **Delete, delete, delete** and don't send unnecessary verbiage to people; even 'the cloud' has a capacity. **Nick Dunlop (Insurers)** shared his great plans for Insurers to:

1. Have a '**Climate Drop-in Surgery**' to provide a neutral space for insurers (then Financial Services Group and then other Liveries) to discuss and get advice on ESG in the London trading market.

2. To establish 'Working Sessions to address the Barriers and Solutions' to sustainable practice in London.

3. To have a **working dinner** on 3rd October 2023 at the Old Bailey, hosted by **Bronek Masojada** (Sheriff elect) to launch 1 and 2.

The emphasis for all 3 of these initiatives is **actions**, **outcomes and impact**. LCAG is so pleased to be working with Insurers for 2 and 3, where we can help and support.

Andy Williamson (Builders Merchants) will share his ESG Policy and light-touch Action Plan for the LCAG Website.

John Clink (Merchant Taylors) has offered 1-to-1 drop-in sessions to help hall-owning companies preparing a Climate Action Plan.

Many thanks to all SPOCs and delegates. There is so much wonderful sharing of expertise, initiative, and altruism in the way we are all working together.
